## Contest Official Rules

### Holiday Solution \$50 to be won

The Holiday Solution \$50 to be won Contest (hereafter “the Contest”) is organized by Benny&Frères Inc. (hereafter “the Contest Organizers”). ### **ELIGIBILITY**

The Contest is open to all legal residents of Quebec and Ontario over the age of majority in their province at the date of entry in the Contest. Employees, agents and representatives of the Contest Organizers, their affiliates and subsidiaries, their advertising and promotion agencies, suppliers of prizes, material and services related to the present Contest, and any other third party related to the present Contest, as well as the members of their immediate families. For the purpose of the present Contest, the term “immediate families” is defined as a father, mother, brother, sister, spouse or common-law spouse, children, and any person residing in the same household or domiciled with any such employees, agents or representatives.

### **DESCRIPTION OF PRIZES**

#### **Declaration of Winners**

Contest and who does not meet the specific present condition will automatically be disqualified, and another random draw will take place to select an alternate winner. A second identity paper will be required upon claiming the prize.

The winner will be reached by email.

### **CLAIMING PRIZES**

To be declared a winner, a selected entrant must:

- A. Be reached by the Contest Organizers within seven (7) business days following the random draw.
- B. Answer correctly, without assistance and within a limited period, the mathematical skill-testing question that appears on the declaration form (hereafter the "Declaration Form").
- C. Sign the Declaration Form that will be forwarded to him/her and return it to the Contest Organizers within fifteen (15) days after receipt.

By entering the Contest, all entrants accept to comply with the present Contest Rules. Failure to comply with one of the conditions herein mentioned or in any other section of the present Contest Rules will result in the cancellation of the selected person's entry. Within fifteen (15) days of receiving the duly completed and signed Declaration Form OR the moment when an entrant is declared a winner, the Contest Organizers will contact the Contest winner with information on how to collect his/her prize.

The winner will receive his/her gift card at home. Failure to comply will result in the selected entrant's disqualification, and no other random draw will be held, and the prize will be cancelled.

### **GENERAL CONDITIONS**

**Verification.** All Contest entry forms are subject to verification by the Contest Organizers. **Non-compliance / Non-eligibility.** Any entrant whose name is randomly drawn for the purpose of the present Contest, and who does not respect the eligibility conditions, will automatically be disqualified, and a new random draw will be held to find a new winner. Any

**Acceptance of a Prize.** Any prize must be accepted as awarded and described in the present Contest Rules, and cannot be transferred to someone else, substituted for any another prize or for cash in lieu, in whole or in part, subject to the specifications provided in the paragraph that follows.

**Refusal to accept a Prize.** A selected entrant whose name was drawn at random that refuses to accept the prize under the terms of the present Contest Rules releases the Contest Organizers from any obligation related to awarding the prize as it applies to the said person.

**Modification.** The Contest Organizers reserves the right, at their sole discretion, to cancel, modify or suspend the present Contest, in whole or in part, or terminate it, should a human intervention, an error or an event occur that could modify or adversely affect the administration, security, impartiality or conduct of the Contest, subject to approval by the Competition Bureau, if required.

**Premature Termination of the Contest.** Should, for any reason, the computer system be unable to record all Contest Entries during the Contest Period, for any reason whatsoever, or if the contest must be terminated in whole or in part before the end date of the Contest as provided in these rules, the Contest Organizers will hold a random draw among all the duly recorded entries during the Contest Duration, or until the date of the event that terminated the ability to enter the Contest.

**Prize Limitation.** In all cases, the Contest Organizers, their suppliers of products and services relating to this Contest will not be required to award more prizes than the number stipulated in these Contest Rules.
